On 2/9/04 at appx. 1930 hrs I heard Haverhill PD get dispatched to a single motor vehicle collision on Route 112 near the weathered barn. Sgt. Cecil Smith responded. I over heard Grafton Co. Dispatch relay that the reporting party could see a single female in the driver's seat smoking a cigarette. I responded from Route 302 in Lisbon.

While enroute I heard Sgt. Smith sign off and a short time later Woodsville Fire and rescue. Sgt. Smith reported the female was no longer with the vehicle. Responding Units began to look for a female on foot. I traveled Route 302 to Route 112. When I reached 112 I saw a dark colored Subaru sedan at the Junction with 302. I asked the female driver, who I did not identify, if she had seen a person on foot as she traveled the road, she said she had not. I continued up 112 with my spotlight on checking the roadside as I went but did not see any evidence of foot travel on the road or the shoulder. When I entered into Swiftwater village I saw a female know to me as:



Robinson was on foot. I asked if she had seen anyone walking? She told me she had not. She had just come from the Stage Stop Store Route 112. She further advised no one had been in the store while she was there. She told me 'Bill', the storeowner, was closing up.

I arrived on scene and spoke with Sgt. Smith. He advised he still had not found the driver. I told him I would check the surrounding roads and see if I could find anyone. I saw a dark colored Saturn had struck a tree on the eastern side of the corner at the Weathered Barn.

I cleared the scene and traveled Route 112 West to Porter Road, crossed the covered bridge and spotlighted the Big Eddy parking lot but did not see anyone nor any vehicles. I took the left onto Plains road and traveled to Route 302. I drove 302 into Woodsville taking the left onto Swiftwater Road. I traveled Swiftwater Road onto Goose Lane to French Pond Road. I traveled French Pond to Route 116 where I took the right travelling 116 into Haverhill. I had my spotlight on whenever possible. I did not see anyone on foot nor did I note any track on the road or leaving the roadway. I cleared the scene.
